季淳钧博士是伟高达创业投资的董事总经理以及投资委员会成员,同时是新加坡创投及私募股权协会主席。

季博士从事中国及东南亚地区在线游戏,教育,在线旅游,电子商务以及金融服务领域的投资。是以下被投资项目的董事会成员,包括精进电动,Matchmove,爵瑞堡斯,如美家,邀乐网,麻辣马,Playpeli,加州洲际大学,爱乐奇,汉维仓储和北京十分科技。此前也是剑桥工业信托,尚凡资讯,悠悠村的董事会成员,以及亚洲美食台的代理董事。季博士参与了以下项目的退出/部分退出:悠悠村(中国出售),尚凡资讯(台湾上市:5278),剑桥房地产信托基金(新加坡上市:J91U以及出售),Real Time Gaming Asia(新加坡出售),TWG tea(新加坡出售)以及亚洲美食台(新加坡出售)。

季博士持有CFA证书,以工程学一等荣誉学士毕业于英国剑桥大学,在美国麻省理工大学取得博士学位,博士期间以组织知识和信息技术为专业。

Dr. Jeffrey Chi is a Managing Director of Vickers Venture Partners and a member of its Investment Committee and is currently Chairman of the Singapore Venture Capital & Private Equity Association.

Dr Chi has investments in China & SE Asia in online games, education, online travel, e-commerce and financial services. He is a member of the board of directors of Jing Jin Electric, Matchmove Pay, Alo7.com, Kuyun Interactive Technology, Cardvalue, Roomorama, Spicy Horse, Play Peli, California Intercontinental University, Chinaway and Tenfen Technology. He was formerly a board member of Cambridge REIT, Sunfun Info and UUCUN as well as an alternate director of the Asian Food Channel prior to their successful exits, Dr Chi was also involved in the exits/partial exits of UUCUN (trade sale, China), Sunfun Info (IPO TT:5278, Taiwan), Cambridge Real Estate (IPO SGX: J91U & Trade Sale, Singapore), Real Time Gaming Asia (Trade Sale, Singapore), TWG Tea (Trade Sale, Singapore) and Asian Food Channel (Trade Sale, Singapore)

Dr. Chi's experience covers a variety of industries including information technology, healthcare and media. Formerly a corporate finance specialist with and Executive Director at Pegasus Capital, he has managed engagements for large and small clients in both the public and private sectors. Prior to Pegasus Capital, Dr. Chi was a senior consultant with the Monitor Group. Dr. Chi's operational background includes seven years on the management team of an engineering group with operations in Singapore, Malaysia, Taiwan, China and Indonesia. As its Managing Director, he led the group into the Enterprise 50 in 1997 in Singapore.

Dr. Chi is a C.F.A. Charter holder and graduated from Cambridge University with 1st Class Honours in Engineering. He earned his PhD from the Massachusetts Institute of Technology in organizational knowledge and information technology.

斎藤茂樹先生是日本SIP(Strategic Investment Partners, Inc.)CEO和日本创业投资协会(JVCA)理事(2008年一今)。他是日本企业家转型到风险投资行业的代表人物。斋藤先生负责规划和指导公司的商务战略、搭建战略资本架构和管理体系。由于他在高科技风险行业IPO经验和企业孵化经验,斋藤先生和其公司投资的投资组合公司的CEO能够长期通过相同的角度沟通合作。

斋藤先生出生于1961年,毕业于东京大学经济学系。1985年他加入刚刚私有化的日本电报电话公司(NTT),并负责该公司大宗交易的销售和市场关系网络合作工作。1997年,斋藤先生获得麻省理工学院斯隆商学院MBA学位,专攻高科技企业风险投资商业管理领域。在网景通讯公司(Netscape Communications Corporation)负责组建该机构在日本的门户网站业务;担任Digital Garage Inc.代理董事和首席运营官,负责为该公司提供面向主要金融机构战略层面的互联网解决方案。斋藤先生通过多年的工作经验,逐步发展出一套面向主要金融机构的新业务发展模式理论,并命名为sponsored incubation(资助型孵化器)。同时,他作为主要负责人,领导了Digital Garage及其他孵化成功企业的IPO,包括目前市值高达450亿美元的日本价格网(Kakaku.com)。

斋藤先生在2004-2011年期间在日本私立大学数字好莱坞大学(Digital Hollywood University)担任本科层级的教授。斋藤先生的出版物包括日经BP社出版的《令人震惊的数字传输》(Shocks in digital conversion)和丸善出版株式会社出版的《创新生态系统和新增长战略》(Innovation Ecosystem and New growth strategy)等。

Mr. SAITOH is CEO of Strategic Investment Partners, Inc. and Director of Japan Venture Capital Association (2008-present). He is an entrepreneur-turned venture capitalist. He plans and directs the firm's business strategy, strategic capital structure and management system. With his high-tech venture IPO and business incubation experience, he can readily see from the same perspective as and communicate well with the CEOs of portfolio companies.

Born in 1961. Graduated from The University of Tokyo, Majored in economics. Joined NTT in 1985 when it was privatized. Engaged in sales and marketing of communications networks for large accounts. Received an MBA from the MIT Sloan School of Management in 1997, with a focus on high-tech venture business management. Joined Netscape Communications Corporation organizing their portal business in the Japanese Market. In Digital Garage Inc., provided strategic internet solutions to major companies as Representative Director and COO. Developed a unique method of new business establishment with major companies, called sponsored incubation. Co-led IPO of Digital Garage and led IPOs of other incubated companies, including Kakaku.com (currently US\$4.5 Billion market cap).
